Yale University and Paris-Panthéon-Assas University have agreed on the initiative of a common **Summer School, all held in english**, designed for selected **Law and/or Economics students** interested in **Contract Arbitration and Alternative Dispute Resolution (ADR) in an international context**.

Courses will be held in English and will include classes in law and economics taught by French and American scholars, focusing on dispute resolution and contracts.

The Yale-Assas Summer School will be held from: **June 22, 2026 to July 17, 2026**

- > **Duration:** 4 weeks
- > **Language of teaching:** English
- > **Course load:** 65 hours (class + seminars)
- > **Classes:** Monday to Friday (typically from 9:00 am to 1:00 pm)
- > **Social and cultural events:** organized on certain days (visit of museums or institutions)
- > **Group profile:** around 15 participants from each of the 2 institutions
- > **Location:** Paris-Panthéon-Assas University, 92 rue d'Assas, 75006 Paris (FRANCE).

#### APPLICATION CRITERIA

To apply, students must meet the following criteria:

- > hold a M1 or M2 (preferably in Economics, Law or Finance) by the start of the Summer School.
- > or be enrolled in a Grande École or a Political Science Institute.
- > subject to approval by the program manager, L3 candidates may be considered.

Preference will be given to students in their 4th/5th year of studies ([M1/M2](#)) and PhD students.

Applicants must have a sufficient command of the English language for studying the required readings and participating in rigorous classroom discussions.
